ELIGIBILITY

• Watercolor • Gouache • Cassein • Egg tempura • Acrylic •

- ⇒ The exhibition is open to all artists 18 years of age or older working in 2D water media on paper only.
- ⇒ No Yupo or watercolor canvas, no pastels, oil pastels or prints, no digital images or reproductions.
- ⇒ Collage elements must be original work on watercolor paper and represent no more than 10% of the painting surface. All work must be matted in white or pale neutral, and framed under plexiglass for exhibition hanging.
- ⇒ Artists original work only. No supervision/class work. No copies or likenesses or other artists' work, including photographs or references not created by the artist.
- ⇒ Work must have been completed within the last two years and not previously exhibited in prior RRWS national juried exhibitions.

ENTRY PROCEDURE

- ♦ Each artist may submit up to two paintings; only one may be selected for exhibition.
- ♦ Entry fee is \$25 (RRWS 2012 members) or \$35 (non-members).
- ♦ Show image only, no frame or mat. Images will not be returned and become the property of the RRWS.
- ♦ This is a blind juried submission process.

DIGITAL ENTRIES

- ♦ All entries must be in JPEG format on one Compact disk.
- ♦ Resolution 300 ppi with minimum of 1200 pixels on the longest side.
- ♦ Image must be correctly oriented (vertical or horizontal)
- ♦ No digital enhancement is allowed.
- ♦ Title the digital file as: Lastname_Initial_ArtworkTitle.jpg
- ♦ e.g. Jones_Q_FlowerGarden.jpg
- ♦ Label CD with permanent marker as shown

RRWS Signature Status

RRWS Signature Status, signified by the letters RRWS, is obtained by a member's acceptance in the RRWS national show for three years during a ten-year period. *Please submit membership fee (\$20) with entry for signature status eligibility. Continuous paid membership is required.*

Donna Zagotta’s paintings have evolved from an early emphasis on traditional watercolor techniques and traditionally influenced realism to an unconventional use of the watercolor medium and the exploration of the area that lies between realism and abstraction. Donna has a passion for art history with a special interest in Modernism and finds inspiration in the work of Edouard Vuillard, Henri Matisse, and Richard Diebenkorn, master painters who were more focused on expressing color and spatial ideas than in rendering the particulars of subject matter.

Active professionally for more than 20 years, Donna is a nationally recognized artist, teacher, and juror. She has accumulated numerous awards and is a signature member of the American Watercolor Society, National Watercolor Society, Watercolor West, and Transparent Watercolor Society of America. .She recently filmed a DVD for Creative Catalyst titled “The You Factor: Powerful, Personal Design in Opaque Watercolor”, and her work appears in numerous publications, most recently in Issue 37 of The Palette Magazine and the October, 2010 Watercolor Artist Magazine feature article titled, “Altered Sensibility.” Donna has been teaching classes and workshops since 1990 and RRWS is extremely excited to welcome her as instructor and juror for its 19th National Juried Watermedia Exhibition.
